This would then pre-emptively answer the Examiner's question of whether the Qualifying Body agrees with the recommended changes.

Cllr Gladwin proposed that EPC go with what O'Neil Homer has proposed. This was seconded by Cllr Brennan and all were in favour.

Time limit – we proposed 7 years for the planning application as we are unsure how long the Community Centre will take to get built and functioning. Proposed by Cllr Gladwin and seconded by Cllr Brennan. All were in favour.
