#### 3. Declaration of interests in items on the agenda

Cllr. Beecham: item 16 (secretary of the South Green Residents Association)

It was discussed whether Cllr. Beecham's interest is pecuniary or non pecuniary. Cllr. Redding stated that if the Parish Council were to make a contribution to the repair of the South Green tracks then all of the frontagers would effectively accrue an indirect financial gain as their potential contribution to the overall cost of the maintenance works would be reduced.

Cllr. Bell proposed a motion that Cllr. Beecham be allowed to vote on item 16 as would be the case if the interest was non pecuniary. However the motion was not seconded.

No vote was taken on the question of the interest being pecuniary or non pecuniary.

#### 16. South Green

Cllr. Beecham (secretary of the South Green Residents Association). Is Council prepared to contribute financially to the repairs to the South Green tracks?

Council spent a long time discussing this subject without reaching any conclusions. It was discussed whether posts should be put at the western end of the track to stop through traffic. It was agreed that Council are to wtite a letter to Mr Gooch requesting a meeting between the three parties. Cllr. Beecham is to provide the costs for equipment and labour.

An update on the repairs required and the possible application for a grant to fund those repairs.

Cllr. Beecham has received a document with questions regarding this.

## 18. Matters Raised by Councillors for the next agenda or for information only

Cllr. Sly would like allotments to be added to the July agenda.

Cllr. Bell: the handyman has requested training to be using weed killer and for health and safety purposes. The question of when posts would be put up on North Green was raised. Cllr. Bell will look at previous minutes on the posts.

The lower branches of the trees on the North and South Greens and also the tree by the Community Centre need looking at. Cllr. Bell asked Mr. Brian Jennings to look at and quote a price.
