Highways

The Cabinet Member for Highways, Cllr Rodney Bass has launched a new scheme for elected Members to enable face to face meetings with Parish and Town Council Chairmen through their County representative. These sessions are held every Tuesdays except full council meetings and holidays and can be booked through me.

Floods

Exactly two weeks ago our County was faced with the most challenging flooding events since 1953; The Council's emergency services team joined forces with the affected District Councils to ensure that as much protection to resident was given; a decision was taken to evacuate several areas as a direct result. Thankfully the combination of events did not materialize to the maximum extent and 100% safety was maintained in all area; the response from all emergency planning partners involved was outstanding with many TDC officers spending the night of 6th December and most of the Saturday on emergency cover duties and they must all be commended for their efforts.

CIF Granting

ECC has this year given out £1.440.000 in Community Initiative Funding to match fund projects led by Town and Parish Councils across Essex; the money was split between the 12 Districts equalling £120K each. This initiative has been running for several years and provided funding for many community groups across Essex, which is a primary reason why this has not been withdrawn. (yet..!)

China Links

ECC has long recognized the need of forging stronger links with China, who are currently one of the most successful economic powerhouses in the world; the direct result of this very strong established relation is the massive investment that China has already made in Essex, with Harwich being a prime example, and we have also secured Fire Prevention Training to officers from the Jiangsu province, which could potentially lead to considerable future opportunities. The Chancellor George Osborne announced an extra £50billion to boost foreign trade with a special emphasis on those markets, recognizing our own efforts here in Essex.

"Legal Highs"

ECC has launched an awareness campaign about the potential dangers of the so called "legal highs" or novel psychoactive substances; the Council's Trading Standards and anti-Drugs and Alcohol team are working with partners such as the police and crime reduction partnerships to ensure that the practice of selling these legal "cheap drugs" is terminated. All retailers have a duty of care to ensure that the products they sell are safe and not harmful to consumers who mostly happen to be young people.

Central Government is currently reviewing the UK's Laws and Enforcement against these NPS's; in most cases retailers are not at all aware of the potentially lethal contents of these legal stimulants and if they are unable to ensure that these products are safe to sell and meet all legal requirements they should stop selling or face action against them.

New Mower

Handyman's Wages

It was resolved at the above Finance Committee to give the handyman Alan Dingwall a pay rise to Spinal Column Point 18 which is £9.01 per hour. Alan is currently on £8.60 per hour (which equates to Spinal Column Point 16). A review would be due in the next 6-12 months.

Yellow Book – Cost £55 from EALC

It was resolved at the above Finance Committee that the clerk bring her yellow book (**Charles Arnold Baker** Local Council Administration 9th Edition) to the full council meeting.

An extra bit about the book is below:

Arnold-Baker on Local Council Administration is a complete statement of the law relating to parish and community councils, in the form of an extensive though succinct narrative accompanied by comprehensive statutory materials.

Now in its 9th edition, this work has been thoroughly revised and updated to take into account recent legislation, including:

- the Pensions Act 2008
- the Bribery Act 2010
- the Equality Act 2010
- the Charities Act 2011
- the Localism Act 2011
- the Growth and Infrastructure Act 2013
- the Accounts and Audit (England) Regulations
- and the 2011 Code of Practice on Publicity

This is a key text for parish and community councils, local authorities and solicitors practicing in local government and public/administrative law.

Chainsaw Course – Alan Dingwall

It was resolved at the above Finance Committee to send handyman Alan Dingwall on a chainsaw course in Thorpe. This was Alan's preferred location for a course. The breakdown for the course in Thorpe is:

Safetymen - Thorpe le Soken ID badge and certification for 5 years Mileage allowance - 45p per mile Brightlingsea to Thorpe - approx 10 miles - 21 minutes (according to Google) Total mileage = 20 miles Total mileage cost = 0.45*20 = £9.00 Alan's hourly rate £8.60 Total travelling time = 45 minutes (rounded up from 42 minutes to 45 minutes) Time at course - 7 hours 15 minutes Total hours - 8 hours Total cost for Alan's time = 8 * 8.60 = £68.80 Course cost - £149.00 Total expenditure - £9.00 + £68.80 +£149.00 = £226.80

The parish council did not originally get sent a notice of the appeal. Vikki rang the planning office to find out why they had not sent a notice out to the Parish council she was told that they had sent one out to us, we just hadn't received it yet. Vikki requested that they sent a copy out through email which they did.

It is recommended that the Parish Council send in their original objections to the inspector as they do not need expanding on and these are the two main reasons that TDC refused the application.

14. Moto Cross Activity in Church Road – To listen to an update from Matthew Lang Dear All,

I am emailing to provide you with an update in respect of the Moto-Cross issue in Church Road, Elmstead Market.

We have now had the opportunity to meet with the owners of the site to discuss the issues that have arisen from their use of the land for Moto-Cross purposes. In response to our meeting we have received the attached letter from the owner which he has circulated to all of his staff.

As you can see the owners have agreed not to re-commence the use until April 2014 and only on 14 Saturdays throughout the year, avoiding Sundays/Bank Holidays. The land does have permitted development rights which enable its use for Moto-Cross purposes 14 days within a calendar year and the owners propose to keep within this limit. As such use of the land as proposed would not represent a breach of planning control. However, please be reassured that the site will continue to be monitored in terms of the number of days it is used and spot checks will continue throughout 2014.

In respect of noise levels, the owner has agreed to carry out his own noise measurements and will liaise with Environmental Health in this respect. For any action to be taken in terms of noise, Environmental Health would need to satisfied that a statutory nuisance exists taking into account the frequency, duration and location of the events.
