Mr Woodhouse said he did not intend to deceive the Parish Council or TDC regarding the plot of land. He apologised for any trouble caused. In hindsight he said he thought it would have been a good idea to talk to the Parish Council and neighbours.

- The hardcore was to make a vehicular access, due to the muddy nature of the access into the field.
- The concrete base was for a few stables
- The sceptic tank was dropped in the hole and popped back up as the ground was so wet. It
 was intended to be a waste facility for the static caravan.
- Mr Woodhouse said that they have no connections with either The Whitings or any travelers.
- Appropriate channels will be followed in future.
- The land is classed as agricultural land, so will need to apply for change of to residential.

All work has now stopped and a planning application will be forthwith for a single residential house, as the land in is the village envelope.

The design will be discussed with TDC and the Parish Council.

Mr Woodhouse went on to say that as soon as they are able to tidy up the site they will. The stop notice is in place until the 28th March.

Under the guidance of the planning officer he saw earlier, the application will include the work they have already done. They will then have to apply for outline planning permission.

- 3) Who will cut the grass during the build programme?
