After £117million savings have been achieved in this year's budget it looks very unlikely that further consultations to cut services will take place in the incoming year.

# A120 speed and accident reduction

A meeting took place last Friday 2<sup>nd</sup> May with Bernard Jenkin MP, Cllr Rodney Bass ECC Cabinet member for Highways, Highways Agency representatives, local District and Parish Councillors and I to discuss the non-delivery of the promised average speed cameras and the long term solution to accidents on the A120 stretch between Pellen's Corner and Hare Green. The cameras which were due to be installed last March have been delayed firstly because of the bad weather and secondly because as the contractor's term with the HA had come to an end there is now a delay with the incoming service provider.

The four sets of cameras have however been purchased and will hopefully be installed in June.

### **New Waste Plan**

The Minerals Plan which will provide enough building base materials for the next twenty years, has now almost been completed with an Inspector considering it sound, albeit some modifications which are not in our area.

This will now pave the way for Officers to concentrate on the New Waste and Recycling Plan which might now entail a new possible new call for sites; this will prove quite controversial as the very nature of its description will make residents very nervous about where these will go. Early indications lead us to believe that our area will not be affected as we have a new Waste Transfer Station almost built on our doorstep on the A120 which will process all of the Colchester and Tendring combined household waste.

# Residents can now speak at Essex County Council meetings

Residents are to be given the chance to ask questions, raise concerns or voice support for items being discussed at future Essex County Council meetings.

The move, agreed at last Tuesday's Full Council, is designed to increase public participation in the Council's decision making process. It is also part of the Council's commitment to be as open and transparent as possible. People will now be able to address for up to three minutes Full Council, Cabinet and Scrutiny Committees on items on that meeting's agenda. Up to 15 minutes will be set aside at the start of Cabinet and Scrutiny Committees, with up to 30 minutes available at the beginning of Full Council.

Anyone wanting to ask a question at a Cabinet or Scrutiny Committee meeting will be able to register their request when they attend the meeting. For Full Council meetings however they will need to submit their question by 10.30am seven days before the meeting.
