District Councillor Fred Nichols sent the following report:

The Old Post Office, as you may be aware the sale has fallen through, owing to an English Heritage issue (which was not really an issue). However a new purchaser is in the frame and I am informed looks very likely to be positive news.

The new Local Plan will be discussed on Tuesday 21st October at the Princes Theatre, Clacton On Sea. There are two proposed sites for Elmstead, Meadow Close and Church Road. The Charity Field is not included.

Brightlingsea by election for Essex County Council was won by Alan Goggin who has taken the seat from UKIP, following Roger Lord's decision to resign his seat

Appendix 2 – Item 14/146 - 14/01438/OUT Development of 7 no.3 bed family homes with ancillary parking and amenity space – Land adjacent to and behind car park, Clacton Road, Elmstead

Ian Johnson from Duncan, Clark and Beckett was in attendance to answer any questions the councillors had about the outline application.

Ian Johnson introduced himself and said that he was aware of the local plan changing and that this application could reduce the chance of building elsewhere in the area. He was also aware that the application location is outside of the village envelope and at the moment it was just an idea to get something approved/put in place

Concerns were raised about traffic accessing and exiting the development, car parking and about the wildlife.

Ian Johnson said that that the 1<sup>st</sup> 6 metres of the 'driveway will be 5.5 metres wide. After 6 metres it will be 3.7 metres wide. This is so that cars can pass each other and do not have to wait on a busy road.

Car parking- there are 3 car parking spaces per house, which should be adequate. As for the wildlife, an ecological survey will be carried out and if anything is found then it will be moved to another appropriate location.
